PURPOSE OF TONIGHT'S DISCUSSION

- The Methacton Board of School Directors are in the process of considering renovations, new construction, or a combination of both for Arrowhead Elementary School.
 - Allow the Board of School Directors to provide initial input on matters that should be considered as the process proceeds forward.

SUMMARY OF PROCESS/DISCUSSIONS TO DATE

- Facilities Assessment Completed April 2016
 - Assessment all district facilities shows a projected needed investment of \$14,478,750 (revised 2018) to Arrowhead Elementary School in the next 3-5 years from assessment date
- School Consolidation Discussion led to Closure of Audubon Elementary School in 2016
- Facilities Master Plan Developed & Work Followed Summer of 2018.
 - High School MEP & Roof and Arcola Auditorium
- November 8, 2018 State of the District presentation
- January 15, 2019 Arrowhead Discussion and Recommendation
- January 22, 2019 Board Approves Resolution to continue Arrowhead Elementary as a school building.
- February 2019 Superintendent Recommends Timeline and need for Design professional Services
- February 2019 Superintendent Solicits general input from Arrowhead staff
- March 2019 Board discusses considerations for path forward


