# Background

- Request for Proposals (RFP) for architectural services was prepared and issued on 2/6/2024
- RFP advertised via direct emails to nine (9) architectural firms
- Pre-Proposal meeting and High School tour was conducted on 2/8/2024



# Background

- Four (4) proposals were received by the 2/19/2024 proposal deadline:
  - Breslin Architects
  - Crabtree Rohrbaugh & Associates
  - KCBA Architects
  - SCHRADERGROUP



# **Proposal Evaluation and Initial Interviews**

- Firm evaluations were a multi-step process
- Step 1
  - Administration completed evaluations for each of the four (4) proposals based on responsiveness to the RFP requirements (Organization and Project Team, Firm Competency, Process, Work Schedule, Insurance, and Fee Proposal)
  - All four (4) firms were invited to an initial interview, which included a presentation by each firm, on 3/4/2024
  - Two (2) highest scoring firms advanced to Step 3 which was conducted on 3/14/2024



## **Finalist Firms Evaluation**

- Step 2
  - Presented process update to Property Committee of the Board of School Directors on 3/12/2024
- Step 3
  - On 3/14/2024, the two (2) short-listed firms asked to prepare responses to pre-prepared questions
  - Interview committee composed of multiple Administrators and three (3) representatives of the Board of School Directors
  - Firms were evaluated based on rubric criteria
  - Finalist firm, SCHRADERGROUP, was recommended by the selection committee
